1 Opening of the General Assembly (GA)

1.1 Welcome

The Vice President Stefan Busemann, welcomed the attendees at the General Assembly 2021. Due to the COVID-19 crisis, the event took place online. The assembly started at 13:00 h on the 13st of April 2021.

35 members attended the GA in person which means 35 valid votes.

1.2 Attending Board and BCC members

All members of the Board and BCC were present.

2 Election of the person in charge of counting the votes

The General Assembly elected Rachel Fourcard as the person in charge of counting the votes.

Result: 19 accept, 0 against, 0 abstain.

3 Acceptance of the GA protocol 2020

Stefan Busemann asked the attending members if they accept the protocol of the GA 2020.

Result: 15 accept, 0 against, 5 abstain.

4.1.1 Trademarks registrations and oppositions

Report of Ric van Westhreenen, responsible for the trademark:

In 2020, we worked on trademarks in India and in Ukraine. India:

- The trademark "TYPO3" has been filed in India in classes 09 (software), 41 (trainings related to the use of software and development of websites) and 42 (development of software, development of websites)
- An opposition has been raised in 2019 against the Indian trademark "TYPO" No. 4179123. In 2020, we submitted affidavits and proof of anterior use of your own trademark "TYPO3" in India.

Ukraine:

- The trademark "TYPO3" was filed in Ukraine in 2019 but refused by the Office in 2020 because of the earlier trademark "TYPO3" No. m201804231. In 2020, we requested a suspension of the examination procedure until the end of the opposition procedure (see next point below). After the end of the opposition procedure and cancellation of the trademark "TYPO3" No. m201804231, the trademark "TYPO3" was finally registered.
- An opposition has been raised in 2020 against the Ukrainian trademark "TYPO3" No. m201804231. The opposition was successful and the trademark "TYPO3" No. m201804231 was cancelled.

4.2 Annual report by Business Control Committee (BCC)

Report by Ingo Schmitt, Chairman of the BCC

- The communication with the TYPO3 Board is on a stable and good workflow.
- The final bookkeeping is in good order.
- Some projects have used only a small percentage of the granted budget (Corona sucks!)
- New budgets were created.
- Discussion with the board about the role of the BCC started, to support budget owners and the board for a better work (not only financially) with the budgets.
- The bookkeeping for the GmbH is in good order.


6 Disencumbering of members of the board, cashier, accountants and commissions

- Core Team: Released TYPO3 v10 LTS in April 2020 and 14 maintenance releases for version 10.
- **Demo Project Team:** Founding of the official TYPO3 Demo Project Team and release of the demo website
- **Design Team:** Development of an online style guide to make the many hidden rules in the TYPO3 universe more visible
- **Documentation Team:** brand new Sphinx-TYP03-Theme for documentation, Team size increased
- Education Committee: Online certification (since June 2020) TYP03 certifications ready for 10LTS - online event to replace certification renewals at CertiFUNcation
- Localization Team: Switch from a self-hosted Pootle instance to the SaaS solution Crowdin
- Marketing Team: TYPO3 Comparison Cards released
- **Security Team:** coordinated & fixed 42 incidents; started TYPO3 Bug Bounty Program; represented TYPO3 at Google CMS Security Summit in Munich
- **Server Team:** migrated (almost) all services to the new, container based platform; streamlined the individual update process for each service
- **typo3.org Website Team:** Work on all maintained *.typo3.org sites continued, v10 in use.

Question from Felix Herrmann regarding Art. 14 of our By-laws:

"The General Assembly shall decide by open ballot in all cases, unless the General Assembly decides to conduct the vote by secret ballot. On request of a voting member this can be decided with two-thirds majority of the voting members present. In the case of an Internet General Assembly or virtual General Assembly, the Association Board shall ensure that the secret ballot procedure can occur electronically." The question from Felix was:

If someone wants a secret ballot, what type of voting-procedure would be used?

Answer from the board:

If the GA takes place in Düsseldorf in presence, it's easy to hand out pen and paper for a secret ballot. For the webinar it's not so easy to find a solution. If someone complains to our current procedure we need to repeat the GA and find another solution for secret ballots.
